1. The Texas State Pepsi USBC Youth Championship will be held on March 9, 10, and 11 at FORUM BOWL in Grand Prairie, 2001 Great Southwest Pkwy, Grand Prairie, Tx. 75051. Squad times are 9:00 AM, 6:00 PM Friday, 9:00 AM, 11:30 AM, & 3:00 PM on Saturday, and 9:00 AM, 11:30 AM, & 3:00 PM on Sunday.
2. Entrants must be 12 years and over as of August 1, 2011. Entrants bowling in the wrong age division will be disqualified. **Entrants must check in with their USBC card.** Entrants may not qualify more than once from the league level, and must participate in the division through which they qualified.  
League qualifying dates are November 5th thru 18th and January 7th thru 20th.
3. The ratio from league to state is at least one for every 5 bowlers per division or major fraction (3 and 4 are major fractions) including last place ties. In all cases at least one bowler per division shall advance. The advancement ratio shall be applied uniformly to all eligible divisions. Entrants may enter one time only. If an individual qualified and cannot participate in the state competition, replacements will be eligible based on order of finish in the previous qualifying event. Entrants must be TEXAS USBC Youth Division members. No substitutes will be permitted, however, replacements may be used for bowlers not present 30 minutes prior to squad time.
4. Advancers out of the league level must bowl in the division they qualified in during all subsequent levels. If a bowler advances out of league level in more than one state / zone, the bowler must declare one state / zone to continue competing before the next competition level. Participation in any level of competition past the league level in more than one state / zone will result in automatic disqualification.
5. Entrants must use the highest current season average as of February 1, 2012, Minimum of 8 games. If an 8 game average does not exist as of February 1, 2012, but does exist as of February 20, 2012, entrant may use this average. If a current season average, minimum 8 games does not exist, then a final average from 2010-2011 season may be used. Bowlers not meeting the above requirements must bowl with an average of 211. **BOWLERS WITH A 211 AVERAGE OR ABOVE MUST ENTER THE SCRATCH DIVISION.**
6. ENTRY CLOSING DATE IS FEBRUARY 20, 2012.  
ENTRY FORM AND FEES must be postmarked by that date to the tournament director.
7. HANDICAP will be 100% of the difference between the bowlers average and 210.
8. ENTRY FEE is \$37.00 per entry. Entry fee breakdown is \$13.80 Bowling fee, \$18.00 Scholarship / award fee, \$5.20 expense fee. Entry fee must accompany entry. Entry fee will not be refunded. ENTRY FEE MUST BE REMITTED BY CASHIERS CHECK OR MONEY ORDER. ENTRY WITH PERSONAL CHECKS WILL BE RETURNED TO SENDER. Make CASHIERS CHECK OR MONEY ORDER PAYABLE TO TUSBCY. Symbolic awards will be given one for every twenty entries in each division with a minimum of six per division. A towel will be given to each participant. A pin for over average will be given to bowlers qualifying. SCHOLARSHIPS will be awarded on a ratio of 1 for 35 to bowlers in the 12 and over division, with a minimum of \$50.00. Total pins with handicap will be used to determine the qualifiers for scholarships. Award and scholarship fees will be returned 100% to the bowlers. Ties will be added together and divided equally.
9. Entrants will bowl two (2) - three (3) game blocks. Bowlers will have 10 minutes of practice on their starting lanes. All bowlers arriving late shall begin play and the score shall count beginning with the frame that's being bowled. Frames missed shall be credited with a zero. A bowler not present and ready to bowl when it is his/her turn will be credited with a zero for that frame. Bowlers will change lanes after the 1st three games.
10. Total pins scratch will determine the qualifiers from the Boys' Scratch and Girls' Scratch who receive the paid entries into the USBC Junior Gold Championships. Athletes must be USBC Junior Gold Program Members to advance. (No travel reimbursement or stipend will be provided for these bowlers). Bowlers will be competing for additional scholarships at the USBC Junior Gold Championships held July 14 thru 20, 2012 in Indianapolis. Ties for advancement to USBC Junior Gold will be determined by a one game rolloff. If a tie still exists an additional 9th & 10th frame rolloff will be held.
11. Brunswick will donate a bowling ball to raffle. Money derived will be divided between all qualifiers advancing to USBC Junior Gold.
12. ONLY BOWLERS and tournament officials shall be permitted in the settee area.
13. Claims for errors in scoring or general playing rules must be made to the tournament director no later than the start of the next block or 30 minutes after the completion of the tournament. Questionable errors shall be decided upon by the tournament director. All other protests must be confirmed in writing to the tournament director within 72 hours. Each protest under this rule must be specific in itself.
14. Bowlers will be allowed to have one (1) BOWLING BALL ON THE BALL RETURN at all times.
15. PROPER ATTIRE MUST BE WORN. Participants must wear skirts or long pants. NO SHORTS, NO CAPRIS, NO GAUCHOS, NO CROPPED PANTS, NO TANK TOPS, HALTER TOPS, ABBREVIATED TOPS, SLEEVELESS TEE SHIRTS, NO HATS OR CAPS MAY BE WORN. Decision on attire will be made by tournament official.
16. NO FLASH CAMERAS ALLOWED. THERE WILL BE NO SMOKING IN THE AREA WHERE THE TOURNAMENT IS BOWLING.
17. After an entry has been received, and the dates assigned by the tournament management, the entry fee cannot be refunded.
18. All matters not covered by these rules and regulations shall be determined by the State Pepsi USBC Youth Championship Committee. This tournament will be certified by USBC and all USBC rules will apply. The Pepsi National USBC Youth Championship Tournament Committee reserves the right to accept or reject any participant.
