# TOURNAMENT RULES

- 1: The 15<sup>th</sup> Annual Youth Scholarship Tournament sponsored by the Texas State Youth Leaders will be held on March 10-11, 2012 at AMF Spare Time Lanes, 3149 South Cooper Street, Arlington, TX 76015. Squad times will be 10:30 AM and 2:00 PM on Saturday March 10, 2012 and 9:00 AM and 12:30 PM on Sunday March 11, 2012.
- 2: Entrants must be a current USBC Certified youth bowler.
- 3: **ALL BOWLERS MUST SUPPLY PROOF OF AVERAGE!!!** Entrants must use the USBC Certified average as follows:
  - A. Same average used at the Pepsi Championship tournament.
  - B. If no A use the highest season average as of February 1, 2011, minimum 21 games.
  - C. If no A or B. entrant will use highest 21 game average as of date of participation.
  - D. If no A, B, or C. entrants will use their highest 2010-2011 book average of 21 games, including summer leagues.
  - E. If no A, B, C, or D. Entrants must bowl scratch.
- 4: Entry closing date is 30 minutes before squad time. To ensure participation, entrant should mail the entry by February 28, 2012. Entries received after that date, will be accepted on a lane available basis only. All entries postmarked by February 20, 2012 will be placed in a drawing for a \$50.00 scholarship.
- 5: Bowlers may participate in multiple squads or multiple divisions, but can place only once (the highest placement) in the tournament prize list.
- 6: Handicap for the handicap division will be 100% of the difference between the bowler's average and 220.
- 7: Entry fee is \$35.00 per entry. Entry fee breakdown: Lineage is \$13.80; Scholarship is \$18.00; and expenses \$3.20. Mail CASHIERS CHECKS or MONEY ORDERS (**NO PERSONAL CHECKS**) PAYABLE TO THE **TSUSBC**. Scholarships will be awarded on a ratio of 1 for every 10 entries. Scholarship fee will be returned 100% to the bowlers in the form of scholarships. All Scholarships will be held by the USBC SMART Program in the TSYL account.
- 8: Junior Gold event is optional, entry fee is \$35.00. Entrant must be a Junior Gold member or purchase membership (\$30.00) at the tournament. Junior Gold members must show their membership cards. The optional Junior Gold portion will use their six (6) game scratch score. Each day's high place Boy and Girl Junior Gold entrant (subject to 4 girls and 4 boys minimum/day for separate divisions) will receive a \$200.00 entry into the 2012 National Junior Gold Championship if slots are available; otherwise, the entry will be for the 2013 tournament. Other entries will be awarded on a ratio of 1 in 7 entries or major fraction thereof each day. Bowlers may enter the Junior Gold event once each day, as each day is conducted as an entirely separate qualifier.
- 9: Each entrant into the Scholarship Tournament will bowl six (6) games, moving one (1) pair after 3 games (lane 1-2 swap with 3-4 and so forth) within each division. The five highest games will count toward the bowlers' series with the low game not counting. The sport compliant oil pattern will be posted during bowling.
- 10: There will be six (6) divisions: Scratch Boys and Girls, Handicap average 125 and under Boys and Girls, and Handicap average 126 and over Boys and Girls.
- 11: Only bowlers and tournament officials shall be permitted in the settee area.
- 12: Proper attire must be worn. No tank tops, halter tops, abbreviated shirts, revealing attire, and hats or caps. The tournament director will make decisions on all attire. This tournament is being conducted at the same time as the State Pepsi Youth Bowling Championships. The dress code is different.
- 13: The State Youth Leaders Board of Directors shall determine all matters not covered by these rules. This tournament will be certified by the USBC and all USBC rules will apply.
