2021 PROPRIETOR OF THE YEAR

Purpose

The Texas State USBC Proprietor of the Year Award annually recognizes an outstanding bowling center proprietor/manager for his/her enthusiastic support of local, state and national association programs.

Eligibility

Eligible nominees must:

- Be nominated by a local association board
 - Be a current proprietor of a USBC certified bowling center in the State of Texas.
- For the purpose of this award, USBC defines *proprietor* as a person authorized to develop and implement bowling center policies and programs (regardless of whether he or she owns, manages or serves as the general manager of a bowling center)

Please note the following:

- Local associations may nominate only one award candidate per season
- Candidates nominated in previous years, and not selected, may be re-nominated (nominees are not carried over)

Nomination Procedure

To nominate a candidate, you must:

- Complete the nomination form
- Include or attach any additional supporting documentation

Submission

Your application must be made using this official form. Feel free to include any additional information that will support your nomination. All application materials and supporting documentation must be sent no later than **November 1, 2021**. See Section I at the end of this form for information on submission deadlines and procedures.
